
BRIEF INTRODUCTION OF OUR GROUP COMPANIES

The company expanded its operations in Dahej in 2019, focusing on the recovery of liquid Bromine under GPCB Rule 9, with an initial production capacity of 100 MT of high-quality liquid Bromine per month. Since then, the company has significantly increased its capacity and now boasts a planned production capacity of over 1000 MT per month for fine chemicals and intermediates. Additionally, DHRUV REMEDIES PVT. LTD. offers high-end contract manufacturing and research facilities, further solidifying its position as an industry leader.

M/s AKSHAT CHEM INDUSTRIES commenced its operation in the year 2019 at GIDC, Chhatral with GPCB rule 9 permissions for production of fine quality bromine with capacity of 40 MT per month. The company further expanded its manufacturing facility to the capacity of 200 MT per month of bromine compounds.

M/s SHRI LAXMI CHEMICALS, started in the year 2020 with state-of-the-art manufacturing and R&D facility at GIDC, Chhatral, Gujarat. The company has manufacturing facility of more than 300 MT of bromine-based derivatives per month for API’s and Agrochemical Intermediates and fine chemicals.
